CROSS-CUTTING AREAS OF WORK

Ensuring high quality standards and effective use of profiling and displacement data systems through:

- › Field support and capacity building
- › Information management and innovation
- › Advocacy and communications



GOAL I

Joint responses to displacement are informed by comprehensive durable solutions analysis shared by governments, humanitarian and development actors and affected communities



GOAL II

Responses to urban displacement crises are informed by adequate, tailored analysis that accounts for displacement and population vulnerabilities in addition to the wider urban context



GOAL III

Governments and local authorities are able to make an informed choice of displacement data systems that are appropriate for their contexts and intended uses, and are supported to implement profiling exercises as relevant

HIGHLIGHTS 2018

GOAL I: DURABLE SOLUTIONS

Launched the **Durable Solutions Indicator Library** and **Analysis Guide** with partners

Integrated **durable solutions analysis** into field support delivery, including community engagement, to inform solutions strategies (e.g. Sudan) and refugee integration plans (e.g. Greece)

Contributed related expertise to **global processes and events**, including IASC HDN Task Team, GP20 workstream, the Expert Group on SDG indicators (IAEG-SDGs), the UN World Data Forum and the IHL's Course on the Law of Internal Displacement



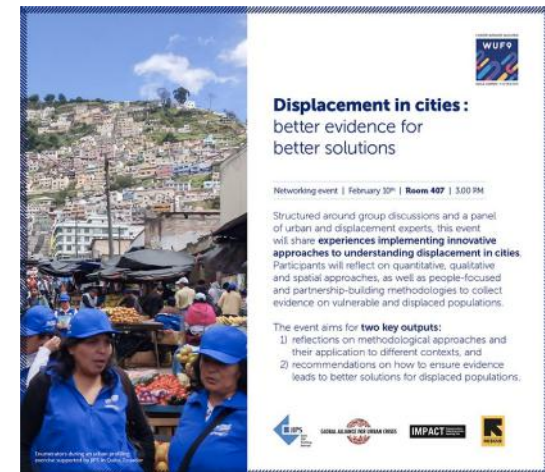
GOAL II: URBAN DISPLACEMENT

Provided support services in urban displacement contexts including Syria, Afghanistan and Ukraine

Developed a **toolkit on urban analysis** with partners based on work in Syria (UrbAN-S) for use in complex conflict-affected cities

Shaped a **common urban profiling knowledge product** alongside partners of the Global Alliance for Urban Crises

Contributed related expertise to **global processes and events** including the World Urban Forum, Refugee Law Initiative and the Global Alliance, and **partners' publications**, including ALNAP, ICRC



GOAL III:

NATIONAL/LOCAL CAPACITY

Led the IDP sub-group of the Expert Group on Refugee and IDP Statistics (EGRIS) to develop **International Recommendations on IDP Statistics**

Supported **locally-led profiling** to enhance ownership and impact in Honduras, El Salvador

Implemented the **Profiling Coordination Training** and integrated profiling into **partner trainings** including official statistics (w/ WB), IDP data (w/ SR-IDPs & UNHCR's Sanremo course)

Shared expertise through key publications including FMR 59: Improving IDP data to help implement the Guiding Principles

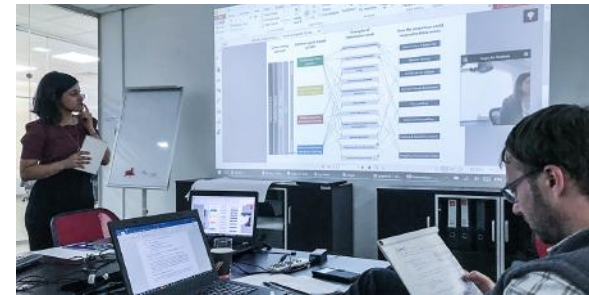


GOAL II: URBAN DISPLACEMENT

Advance support services in urban displacement contexts including **analysis of people and place** and enabling leadership of local authorities in data processes

Develop and deliver two **urban profiling trainings** in MENA based on Syria work/toolkit

Launch the **urban profiling knowledge product** alongside GAUC partners and continue co-leadership of working group



GOAL III:

NATIONAL/LOCAL CAPACITY

Finalise the **International Recommendations on IDP Statistics** with EGRIS partners, contribute to Compliers' Manual and SDG disaggregation process

Deliver first francophone **Profiling Coordination Training** in West Africa (co-hosted by IOM and OCHA)

Organise JIPS' 3rd international conference to advance policy and practice with focus on capacity building for displacement statistics (*TBD*)
